forme of mylye prayere to be used aswell by chyldeid as oþer prayntyme whiche cannot be conuenientlye  
use the hole or þe þayber in our boke of comend prayere to the deþythe is enþe requisite the hole boke  
of the boke titl that our deþeloued subiecte Sylland Cœur of our cyte of lordis statyonis this boke  
vellue hysse spayed hem selfe to his greate chyngis to þynke statye corde of a priuer exgated oute of  
our said boke of oþer prayre fytte to be used þynkelye as chyldeid and dyne oþer our subiectes  
beuing not the mylye of oþer chyngis chal haue foud tyme to tyme occypon to occupye  
þerfore of our greate spesess comend stancis and meþe motionis be haue gretted and gretid þynke  
as by thid þente doo granten and grete þynke and lycence to our said subiecte Sylland Cœur  
and to his assignee for and dyringe the tyme and capte of eþre yeres nexte ensyng the date hyd  
to þynke or cause to be imþynted affinche of bokes of priuer prayre titlled and usally takid this  
eputes for þynke bothe in greate volume and smale whiche tƿe tis chal be sette for the ageynge  
and accordyng to the boke of comend prayre establisched by us in our higher counte of þayber  
þay other þynke oþer lycence to the counte not dychfattynge and forthymore our mynde and as  
þentis is that the same Sylland Cœur and his assignee chal and mynde haue the only þynke  
fond tyme to tyme of the same þynke supynge the tyme aforwade in all booke of volume compas  
þerbyng by thid þente affinche our subiectes aswell þynke and boke vellue as all  
other þone þe they be to þynke vitt or less or cause to be imþynted vitt or less  
within this our counte or in oþer our denaymounþtayre oþer corde or imþessyon of þynke  
or mylne þynke but only eþre to chal be imþynted by the said Sylland Cœur or his assignee  
and accordyng to the true meþing of this our þente lycence this þynke vppon þynke that eþre a  
offendour therin shall forfate to oueruse affinche corde of þynke whiche they be founde  
þerfore be þat it is commandide all our offyce and subiectes as they tende our fauour and leyf  
awarde our displesance that they and eþre of þem if neede require doo abyde and assynder the said Sylland  
Cœur and his assignee in the due execucion of this our lycence. Item þis assynder that the said  
Sylland Cœur chal before they begyn to þynke tyme of the said boke þente a copie þis to be  
imþynted and appioned either by the lordes and oþer of our þynke constaff or by the lorde chanceller  
for the tyme beynge or by our forme ordynary chaplaine or tƿo of þem and þis chal the same be  
challe foud tyme to tyme þynke that eþre by the said lordes and oþer of our þynke constaff or  
or by the lorde chanceller or þis chal haue had of the empes of the said occupacion þe þe þis boke  
þis chal be velle affinche in letters the beynge bounde in þate or booke in lyke wchis it is expised in
