- "Court of summary jurisdiction" shall mean-
 - (a.) As regards Scotland, the sheriff or sheriff substitute, or any two justices of the peace sitting in open court; and
 - (b.) As regards Ireland, any justice or justices of the peace, metropolitan police magistrate, stipendiary or other 5 magistrate or officer, by whatever name called, to whom jurisdiction is given by the Summary Jurisdiction Acts or any Acts therein referred to; and
 - (c.) As regards the Channel Islands, the Isle of Man, and any British possession, the court, justices, or magistrates 10 who exercise jurisdiction in the like cases to those in which the Summary Jurisdiction Acts are applicable.
- "Prescribed" shall mean prescribed by rules made in pursuance of this Act, and for the time being in force.
- "British possession" shall mean any part of Her Majesty's 15 dominions exclusive of the United Kingdom, the Channel Islands, and the Isle of Man, and all places which are under one legislature shall be deemed for the purposes of this Act to constitute one British possession, and, for the purposes of this definition, where there are local legislatures as well as a 20 central legislature, the expression "legislature" shall mean the central legislature only.
- "Foreign country" shall mean any place which is not situate in Her Majesty's dominions.
- "Governor" shall mean the person for the time being adminis- 25 tering the government of a British possession.

For the purposes of this Act the Channel Islands and the Isle of Man shall be considered as forming part of the United Kingdom.

Temporary Provisions and Repeal of Acts.

Application of Act to books, &c. published before Act.

- 72. The provisions of this Act with respect to books, dramatic 30 pieces, musical compositions, paintings, sculpture, engravings, and photographs first published or publicly performed after the commencement of this Act shall extend to those first published or publicly performed before the commencement of this Act, as follows:
 - (a.) The copyright shall endure for the term limited by the 35 existing enactments, or for the term fixed by this Act, whichever is longest:
 - (b.) The proprietor of the copyright shall be entitled to the same rights and remedies as a proprietor of copyright under this Act, except as regards any copies printed or any perform- 40 ance or series of performances commenced or acts done before the passing of this Act.

- (1.) Nothing in this Act shall deprive a person of a right to which he is entitled at the passing of this Act, or of any remedy in respect of any such right:
- 5 (2.) A person who, under the foregoing provisions of this section, becomes entitled to any copyright to which he was not before entitled, shall register that copyright under this Act within six months after the commencement of this Act; but nothing in this section shall require any person to 10 register any copyright to which he is entitled at the commencement of this Act:
 - (3.) Where any copyright has been acquired from the author for [5 & 6 Vict. some consideration other than that of natural love and c. 45.s. 4. affection, the term of that copyright shall not be extended 42.] by virtue of this section, but shall endure for the term subsisting therein at the passing of this Act and no longer, unless the author, if he is living, or his personal representatives, if he is dead, agree with the proprietor of the copyright before the expiration of the last-mentioned term to accept the provisions of this Act with respect to the book, and register the consent in the prescribed manner, and in such case the property in the copyright during the extended term shall belong to the persons named in the agreement.

This section shall apply to aliens entitled to copyright under any 25treaty in like manner as it applies to any British subject.

Proviso as to foreign reprints imported before Act.

- 74. Her Majesty in Council before issuing an Order under this Act applicable to any British possession shall be satisfied either—
 - (1.) That reasonable and effectual provision is made by law in that British possession for causing to be distinctively marked all foreign reprints of any book lawfully imported 5 before the commencement of the Order, as long as the further importation of such reprints is unlawful; or
 - (2.) That such provision has ceased to be necessary.

Limitation of right of action as to past pro-

75. Save as is otherwise provided by this Act, or may be otherwise provided by any Act of a British possession, no action, suit, 10 seizure, or other proceeding which could not have been instituted, effected, or taken if this Act had not passed, shall, by virtue of this Act, be competent in respect of anything done or in respect of any copies of books printed in or imported into any part of Her Majesty's dominions before the commencement of this Act.

Repeal of Acts.

- 76. The Acts specified in the Second Schedule to this Act are hereby repealed as from the commencement of this Act to the extent in the third column of that schedule mentioned: Provided that,—
 - (1.) The repeal of the Act of the session of the tenth and eleventh 20 years of the reign of Her present Majesty, chapter ninety-five, intituled "An Act to amend the law relating to the "protection in the colonies of works entitled to copyright "in the United Kingdom," shall, in the case of each British possession, take effect only on the commencement 25 of an Order in Council under this Act applicable to that possession, or on the first day of January one thousand eight hundred and eighty-one if there is no such order commencing before that day:
 - (2.) The repeal effected by this Act shall not affect the right of 30 any university or college to hold in perpetuity any copyright in any book of which the university or college are the proprietors at the passing of this Act, and every such university and college shall have the same rights and remedies in respect of the copyright so held as are enjoyed 35 by the proprietor of any other copyright:

[Rep., par. 48.] (3.) The repeal effected by this Act shall not affect the rights of any person existing at the commencement of this Act, whether as a British subject, or under any treaty or otherwise; and their rights may be enforced in like manner as 40 any copyright under this Act, and the enactments repealed by this Act shall, as far as is necessary for giving effect .5
